Kelley has transverse myelitis and the Board has voted to donate \$100 to NTAF Southwest Spinal Cord Injury Program (National Transplant Assistance Fund) which helps people suffering. A bucket will be left on stage to collect no pressure voluntary additional donations that attendees wish to make.

Mini meetings are on an as needed basis and will likely be just before the general meeting at Loussac. **The November Meeting is also a POTLUCK.** The club provides turkey, ham and utensils **Bring a side dish!**

Summary of KCK 10/6/09 Board Meeting

- Board members Eric, Sharon, Jim and Luci, along with non Board members Richard, Keith, and Alden attended the meeting.
- Eric indicated reservations for the year were made at the Library. (Editorial comment –Hurrah!!!)
- Much of the meeting was devoted to identifying the topics that would most interest the club members. Keith agreed to make contacts. More topics were developed than could be accomplished this season so it looks like some will have to be invited to speak after summer 2010. Topics included wilderness first aid, stories of water rescue from a water rescue unit, interior river rafting/kayaking, kayaking in the Southeast, kayaking Ketchikan to Juneau, kayaking Price Rupert to Sitka, Dave Sanders of the Federal Park Service for a presentation as well as getting volunteers to help develop hardened campsites in PWS (and elsewhere???), pacrafting, a night of commercial vendors highlighting their trips and services, raft ventures. [Some topics may be excluded- sorry]
- The Board voted to make a \$100 donation to the NTAF. Members will be invited to make (a no pressure) voluntary contribution after the movie shown at the October meeting. Keith viewed the movie 3 Women 300 Miles and indicated it is a superb journey well worth watching and presenting to the club.
- The Board passed a resolution regarding providing scholarships of up to \$100 to members who expressed leadership roles in KCK that take recognized outdoor professional training such as wilderness first aid, Learn to Return, swiftwater rescue. Eric indicated this would encourage people to actively participate and lead in KCK activities such as lead or co-lead classes, trips, etc. It also spreads important safety education, an important club goal. Applicants will have to approach the Board and the Board will vote on each request received.
- The Board voted to eliminate the September, November, May, and June Board meeting. (Some of these meetings, while scheduled, were not convened in the recent past). In the event of a need, the Board thought quick meetings could take place before the General Meeting. Richard indicated he would cancel the reservations at the BP Energy Center for those months.
- The Board endorsed a support letter to the State supporting the Chenega Corp developing hardened campsites on Evans Island. These will be privately owned but available for public use.
- The Board voted changes to the By Laws that will be voted on at the November General Meeting by members.

BY-LAWS OF THE KNIK CANOERS AND KAYAKERS, INC.

Mission: The Knik Canoers and Kayakers, Inc. was formed to promote:

- self-powered navigation of rivers and marine waters in Alaska by canoes, rafts, and kayaks;
- conservation of Alaskan waterways;
- safety on rivers, lakes, and marine waters through training and instruction; and
- assimilation and dissemination of information pertaining to Alaskan waterways.

Membership

- A. Membership shall be open to all persons who support the ideals and objectives of the Knik Canoers and Kayakers and have paid their annual dues as set by the board of directors.
- B. Each regular membership is entitled to one vote and each family membership is entitled to one vote per adult.

Meetings

- A. General Membership Meetings shall be announced to all members for the purposes of developing or formulating policy or furthering the objectives of the club.
- B. Club meetings may be held at any time to further the objectives of the club.
- C. General Membership Meetings will be monthly except December. The November meeting will include Board of Directors election for the following year.
- D. Emergency meetings may be called by the President or by a majority of the Board of Directors or by ten (10) percent of the general membership.

Board of Directors

- A. The Board of Directors shall consist of five-eleven members elected by the general membership. The board, following the election, will meet and elect officers (President, Vice President, Treasurer, and Secretary).
- B. Election of board members will be by vote of the membership present at the November General Membership Meeting. Written proxy votes are permitted for those members not able to attend that meeting. The Board shall have the power to appoint new Board members or Officers until the next scheduled election in the event there is a vacancy.
- C. A Board member may appoint a KCK member to act as their proxy at a Board meeting for voting and/or to establish a quorum.

Conduct of Business

- A. Policy formulation and decision making shall be conducted at the board meetings.
- B. The agenda for the next Board meeting may be announced at each General Membership Meeting.
- C. A majority of votes of members present (or a majority of board members for a board meeting quorum including Board members represented by Proxy) shall be required to approve all business except that listed below.
- D. A two-thirds (2/3) majority of the board shall be required to expel members.
- E. A Board quorum is required to propose amendments to the By-Laws.
- F. Any proposal to spend over \$2,000 for an individual item must be communicated and approved by a majority of the Board with at least 5 Board members voting. If 5 Board members are unable to vote, the proposal must be approved by a majority of the General Membership at the next regularly scheduled general meeting.
- G. Any proposed amendments must be communicated and approved by a majority of the members in attendance at a scheduled General meeting.
